RESOLUTION NO. 8-13-79-161

WHEREAS, the Bad River Tribal Council has determined that the Tribal Membership Ordinance is flawed in that no provision is made to add the names of eligible applicants born after September 8, 1978, and,

FURTHER, there is no provision to add the names of applicants who were adopted by the tribal members at regular Tribal election, and,

WHEREAS, Article VII - Final Adjustments of Rolls, Section I of the Tribal Membership Ordinance must be amended as stipulated under Article XI - Amendments, Section I of the Membership Ordinance, and,

NOW BE IT RESOLVED, that Article VII - Final Adjustments of Section I of the Tribal Membership Ordinance be amended to be as indicated on the attached amendment.

CERTIFICATION

I, the undersigned, as Secretary of the Bad River Tribal Council hereby certify that the Tribal Council is composed of seven members, of whom 5 being present constituted a quorum at meeting thereof, duly called, convened and held on this 12 day of August 1979, by an affirmative vote of 3 and Abstain against, and that said Resolution has not been rescinded or amended in any way.

MEMBERSHIP ORDINANCE

AMENDMENT I

ARTICLE VII - FINAL ADJUSTMENT OF ROLLS

Section 1 shall be amended to read as follows:

Section 1 When the filing period ends on September 8, 1978, action taken on all applications shall be reviewed by the Chairman and the Secretary of the Membership Committee.

The name of the applicants, who were confirmed by the Membership Committee as a whole, shall be entered on a roll.

This roll shall be submitted to the Tribal Council for approval by Resolution.

The resolution approving the Membership Roll together with a certification shall then be submitted to the Superintendent of the B.I.A.

(a) The applicants whose applications were found to be incomplete or inaccurate by the Membership Committee as a whole, shall be notified by certified mail as stipulated under Article IV, Appeals, Section 1 (a), (b), (c) and (d) of the Tribal Membership Ordinance.

The applicants who return their completed or corrected applications within the time period as stipulated under Article IV, Appeals, shall be reviewed by the Membership Committee as a whole.

The names of those applicants who are confirmed shall be submitted to the Tribal Council for approval by Resolution. Upon approval the names of these applicants shall be added to the Tribal Membership Roll.


(b) Applicants who were born after the effective date of the Tribal Constitutional Amendment, and are determined to reflect eligibility for Tribal Membership, as stipulated under Article II, Membership of the Tribal Constitution, shall be confirmed by the Membership Committee as a whole, and these names shall be submitted to the Tribal Council for approval, by resolution. Upon approval the names of these applicants shall be added to the Tribal Membership Roll.


(c) The names of applicants who applied for membership by adoption, and who were adopted by majority vote of the Tribal members at the regular Tribal election, shall be submitted to the Tribal Council for approval by resolution.

CERTIFICATION


