RESOLUTION NO. 7-6-83-64

WHEREAS the Bad River Band of the Lake Superior Tribe of Chippewa Indians is an Indian tribe organized under section 16 of the Indian Reorganization Act of 1934, 25 U.S.C. §476; and

WHEREAS the Band possesses rights to hunt, fish, trap, and gather in the areas ceded by the Treaties of July 29, 1837 and October 4, 1842; and rights to fish in Lake Superior as reserved by the Treaty of September 30, 1854; and

WHEREAS the Tribal Council of the Band deems it in the Band's interest to permit the exercise of these rights on the lands and waters within such areas, under the protection and regulation of Tribal authority;

NOW, THEREFORE, BE IT RESOLVED that the Tribal Council and each of the undersigned members of the Tribal Council, acting pursuant to Article IX, Bad River constitution, and 25 CFR Part 81 (1982), requests the Secretary of the Interior to call an election for the purpose of adopting the proposed amendments A and B, attached hereto;

AND BE IT FURTHER RESOLVED that, time being of the essence in the approval of the proposed amendments, the Tribal Council requests the Secretary to schedule the said election at the earliest time practicable and in accordance with law;

AND BE IT FURTHER RESOLVED that the Bad River Tribal Council appoints Arlene Corbine and Margaret Lemieux, as its representatives on the election board, pursuant to 25 CFR §81.8.

Proposed Amendment A:

Shall Article I of the Bad River Constitution be repealed and recreated, to read as follows:

ARTICLE I - TERRITORY AND JURISDICTION

Section 1. The territory of this Band shall extend to all lands embraced within the original boundary lines of the Bad River reservation defined in the Treaty of September 30, 1854, and to land acquired or reserved within or without said boundary lines by or on behalf of the Bad River Band, except as otherwise provided by law.

Section 2. The jurisdiction of this Band shall extend to all lands as defined in Section 1 of this Article, and further, for the purposes of exercising and regulating the exercise of rights to hunt, fish, trap, and gather, the jurisdiction of the Band shall extend to all lands wherein such rights are reserved by the treaties of July 29, 1837, October 4, 1842, and September 30, 1854.

Proposed Amendment B:

Shall Article VI, Section 1, of the Bad River Constitution be amended to create a new subsection (y), to read as follows:

(y) To regulate by enactment of ordinances the exercise of rights to hunt, fish, trap, and gather within the lands described in Article I, Section 2.
