**RESOLUTION NO. 10-3-88-197**

**WHEREAS,** the Bad River Band of Lake Superior Tribe of Chippewa Indians, the Red Cliff Band of Lake Superior Chippewa, and the Keweenaw Bay Indian Community agree that the Lake Superior fishing in the Michigan waters of Lake Superior is an important resource which must be carefully managed to allow for protection and utilization of this resource, and

**WHEREAS,** the above named parties agree that the 1987-88 Agreement governing tribal fishing in the Michigan waters of Lake Superior should be modified in accordance with the attached Amendments.

**THEREFORE BE IT RESOLVED** that the Bad River Tribe hereby ratifies the attached Amendments to the 1987-88 Agreement, and

**BE IT FURTHER RESOLVED** that the Bad River Tribal ordinance regulating tribal fishing in the Michigan waters of Lake Superior shall be and hereby amended as follows:

1. Closed Season. No member shall fish commercially in the Michigan waters of Lake Superior between 11:59 p.m. October 31, 1988, and 11:59 p.m. November 27, 1988.
2. Special October Season. No member shall engage in lean lake trout target fishing during the month of October in all areas except the Keweenaw Bay small boat non-quota area. For the purposes of this provision, possession of a catch in which lean lake trout comprise more than 40% of the total number of lean lake trout and whitefish shall constitute target fishing.
3. No member shall fish during the month of October in the following areas as illustrated in the attached maps 1-4:
  - a. Map 1 -- Copper Harbor: no fishing within a two mile radius of the navigation light at Copper Harbor.
  - b. Map 2 -- Buffalo Reef: no fishing within a two mile radius of Loran C coordinates 8920-x-31856.4, 8920-y-46687.9.
  - c. Map 3 -- Traverse Island: no fishing within a two mile radius of the Island.

- d. Map 4 -- Huron Islands: no fishing within a two mile radius of any of the islands which constitute the Huron Islands.

**CERTIFICATION**

I, the undersigned as Secretary of the Bad River Band of Lake Superior Tribe of Chippewa Indians, an Indian Tribe organized under Section 16 of the Indian Reorganization Act, hereby certify that the Tribal Council is composed of 7 members, of whom 5 members, constituting a quorum, were present at a meeting hereof duly called, noticed, convened, and held on the 3<sup>rd</sup> day of October, 1988; that the foregoing resolution was duly adopted at said meeting by an affirmative vote of 4 members; 0 against; and 0 abstaining, and that the said resolution has not been rescinded or amended.
